CHURCH SAFETY-TEAM ADDENDUM

Firearms Authorization for Group Safety-Team Personnel | Version 2.0

This Addendum is incorporated into and made a part of the Group Use Agreement between T&P Enterprises of Bay County Inc. DBA / Laguna Beach Christian Retreat ("Retreat") and the undersigned church or organization ("Church"). This Addendum must be submitted to the Retreat no later than seven (7) calendar days before the event begins. No Safety-Team Volunteer may carry on Retreat property without prior submission and Retreat acknowledgment of this Addendum.

PROPERTY-WIDE RESTRICTION -- NO ZONE EXCEPTIONS

Firearms restrictions under the Retreat's Firearms Carry Policy apply to every location on Retreat property at all times. There are no designated zones, specific areas, or mapped locations where any restriction is relaxed or does not apply. Safety-Team Volunteers authorized under this Addendum remain subject to all Policy restrictions at all times and in all locations on Retreat property -- including all buildings, cabins, outdoor spaces, waterfront areas, dining facilities, worship spaces, recreational areas, and parking areas.

Part D. Representations, Acknowledgments, and Agreements

By executing this Addendum, the authorized signatory, on behalf of the Church and each designated Safety-Team Volunteer, represents, warrants, and agrees as follows:

1. Each Safety-Team Volunteer holds a valid CWFL and meets all eligibility requirements under Fla. Stat. §§ 790.01, 790.06 (2024) and 18 U.S.C. § 922(g) (2024).
2. Each Safety-Team Volunteer has completed the training documented in Part B within the preceding twelve (12) months, including firearms safety and proficiency, Florida use-of-force law under Fla. Stat. §§ 776.012, 776.013, 776.032 (2024), and current first aid and CPR certification.
3. Each Safety-Team Volunteer understands and acknowledges that firearms restrictions under the Retreat's Firearms Carry Policy apply to every location on Retreat property at all times, without exception and without relaxation based on location.
4. Each Safety-Team Volunteer is an agent of the Church exclusively and is not an agent, employee, contractor, or representative of Laguna Beach Christian Retreat in any capacity. The Retreat does not supervise, direct, control, or endorse the activities of any Safety-Team Volunteer.
5. Each Safety-Team Volunteer's authority is limited to the protection of the Church's own group members. No Safety-Team Volunteer is authorized to conduct campus-wide security, patrol shared areas, detain or confront other guests, or claim authority over persons outside the Church's group.

6. The Church assumes sole responsibility for the selection, vetting, training, authorization, supervision, and conduct of each Safety-Team Volunteer.
7. The Church agrees to defend, indemnify, and hold harmless Laguna Beach Christian Retreat and its owners, partners, officers, employees, and agents from all claims, losses, damages, and expenses (including reasonable attorneys' fees) arising from: (a) any act or omission of any Safety-Team Volunteer on Retreat property; (b) any firearms-related incident involving the Church's group; and (c) any violation of the Retreat's Firearms Carry Policy.
8. The Church has read and agrees to comply fully with the Retreat's Firearms Carry Policy, including the requirement that all restrictions apply to every location on Retreat property at all times.
9. All information in this Addendum is true and accurate to the best of the signatory's knowledge.

Part E. Individual Volunteer Acknowledgment

Each Safety-Team Volunteer must sign below before serving in any safety-team capacity on Retreat property. Original signatures are required.

I, the undersigned Safety-Team Volunteer, have read and agree to comply with the Laguna Beach Christian Retreat Firearms Carry Policy. I acknowledge that I am an agent solely of my Sending Church and not an agent, employee, or representative of the Retreat. I understand that my authority is limited to the protection of my church group's members. I specifically acknowledge that all firearms restrictions under the Policy apply to me at all times and in every location on Retreat property -- there are no areas, zones, or locations where any restriction is suspended or relaxed.
